 - (iii) The officials under orders of transfer shall not be granted Earned Leave by the Competent Authority under whom they are presently working. Leave applications, if any, may be forwarded to the new place of posting for necessary action.
 - (iv) The Heads of Office are directed to send separate reports on relieving of as well as joining of officials from/to their offices latest by 27.04.2012 for updating the data in records.
 - (v) Requests for transfers to different stations/offices made in the EPTRPs circulated and that in the representations received as on date have been considered and stand disposed off with this order.
