2. The following conditions should be mentioned in the promotion order issued by the appointing authority:-

a) His promotion is purely provisional;

b) He will be liable for reversion –

(i) if after a review of the vacancies, it is found that his promotion is in excess of the vacancies available;

Or

(ii) if found unfit for retention in the post of Office Superintendent

c) His promotion and seniority in the cadre of Office Superintendent will be liable for revision at any point of time subject to seniority made in accordance with (i) O.A.No.598 of 2013 filed by Sri RSR Chandra Murthy and O.A.No.1325 of 2013 filed by Sri Manas Ranjan Behera filed before Hon'ble CAT (ii) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (iii) Out come of any other cases pending before the Hon'ble CAT/other Courts.

d) The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure

(Implementation Cell) O.M. in F.No.1/1/2008 regarding Exercising of option for fixation of pay on promotion.

- e) His seniority in the cadre of Office Superintendent will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
 - f) His promotion is subject to outcome of recasting of reservation rosters in the cadre of Office Superintendent in accordance with DOP&T's O.M. No. 36012/45/2005-Estt (Res.) dated 10.08.2010.
3. If the pay of the official has already been upgraded under ACP/MACP scheme, then he will not be eligible for pay fixation consequent to this promotion.
 4. Promotions to the cadre of Office Superintendent in respect of the official is on in-situ basis.
