- **d)**The attention of the promoted official is invited to the MHA's O.M. F.No. 7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No. 01/01/2008 regarding exercising of option for fixation of pay on promotion.

e)His seniority in the cadre of Staff Car Driver, Special Grade will be liable to revision at any point of time, if any bonafide mistake is found with reference to any records.

f)The official will not be eligible for pay fixation consequent to this promotion in case of his pay has already been upgraded in the scale of Staff Car Driver under ACP/MACP Scheme.

g)The above promotion to the cadre of Staff Car Driver, Special Grade is on in-situ basis.
