Sub: Immediate verification by Assessing Officers of the outstanding demands - where Intimation u/s 245 has been issued by CPC and taxpayers have disputed the demands - Reg



Kind attention is invited to the above OM which highlights the procedure to be followed in cases where notice under section 245 has been issued for ITR processed in F.Y. 2015-16. The OM inter alia provides that in cases where the tax payer has contested the demand, CPC would issue a reminder to the jurisdictional Assessing Officers about the contention of the taxpayer, asking them to either confirm or make appropriate changes to the demand within thirty days. In case no response is received from the jurisdictional Assessing Officer within the stipulated period of thirty days, CPC would issue the refunds without any adjustment.

2. In pursuance of the above, CPC, Bangalore has issued reminders to the jurisdictional Assessing Officers through their designation based official emails in respect of 1,49,321 cases of outstanding demands during the first week of February 2016. A list showing the region-wise reminders issued by CPC is annexed to this letter. In all these cases, the taxpayers have disputed the correctness of the demands and have provided their response on the E-Filing Portal. Details of the response from the taxpayers are also available on the Demand Verification Portal of CPC, Bengaluru. As many of these cases are time-barring by 31 March 2016, the jurisdictional Assessing Officers may be impressed upon to examine the response of the taxpayers urgently and take appropriate action in respect of such demand entries in accordance with the guidelines laid down in CBDT Circular No. 8/2015 dated 14.05.2015.

3. In case they have any difficulty in accessing their designation based departmental e-mail address, they may seek the guidance from the O/o CIT(CO) of the region.


